#### **Neil Johnstone – CIHT President**



Neil has over 40 years of experience having worked in contracting, local government and consultancy for Balfour Beatty, Lothian Region, Halcrow, Systra and CONSULT-NJ Ltd. He chaired CIHT's Scottish Policy Forum and became a trustee in 2018 as well as chairing the Appian Board and Learned Society/Technical Strategy Board.
