Travelling in a Woman's Shoes

Transport Infrastructure Ireland (TII) has published the report Travelling in Woman's Shoes - understanding women's travel needs in Ireland to inform the future of sustainability transport policy and design, a study which investigates the needs and travel behaviour:

"The study explores the drivers of car dependency for women including transport infrastructure, significant caregiving responsibilities, safety concerns and equality of access to quality services. Throughout the report policy opportunities are identified to provide a way forward. This study shows us that designing transport thar people will use and love requires new ideas and new level of gender sensitivity in policy and practice."

According to TII CEO Michael Nolan, the study is the first of its kind in Ireland and tells real-life stories that demonstrates the characteristics of women's mobility in Ireland. Exploring the experiences of women travelling in the country, their mobility barriers, and the challenges they face, is a critical part of the sustainability agenda.



Key summary points:

- While women view cycling as good for health, this is negated by unsafe experiences and perception that it is the least and safe way to travel because of a lack of quality infrastructure.
- Attitudes and perceptions of transport are shaped by families from an early age.
- Mothers pass on their experiences and strategies to their children, teaching them to be vigilant and aware of their surroundings. This can perpetuate a car culture and limit choices.
- There is a general concern for climate change, however the link between individual transport behaviours and sustainability is not well understood.

- Cost of parking is a strong incentive to reduce car usage, whilst the full cost of running a car is often underestimated.
- Women in Dublin are the least likely to use a car and are most willing to reduce their car usage even further.
- Behaviour change requires the full support of society and families.
- Beyond Covid-19 flexible working arrangements could influence the distribution of household duties and travel demand.



Review of the Transport Strategy for the Greater Dublin Area

The National Transport Authority (NTA) has commenced review of the 2016-2035 Transport Strategy. This review will assess current plan implementation and guide a strategy update which sets out a transport infrastructure and service investment framework for Dublin, Meath, Kildare and Wicklow to 2042.



Submission deadline for this round of consultation is Friday 22nd January 2021.

Opening of new pedestrian and cycleway crossing at Dunkettle Interchange

The 1.2km stretch of shared pedestrian and cycleway infrastructure has been delivered by Transport Infrastructure Ireland (TII), and Cork City and County Councils as part of advanced works being undertaken on the Dunkettle Interchange Upgrade Scheme.

The scheme aims to minimise environmental impacts and improve cycling and pedestrian facilities. It also allows for access to a future railway station in the vicinity and associated park and ride facilities. **Source**
