

# CIHT Yorkshire and the Humber Award for going “Above and Beyond” during the Covid 19 Pandemic

The aim of this Award is to honor and recognise an individual or individuals in our sector who has gone above and beyond in supporting their business, their colleagues and the industry during the Covid19 Pandemic.

## Criteria for the award

The criteria for the Award are:

- Have provided a tangible benefit to a business, their colleagues or the wider industry.
- **Commitment:** applicants need to demonstrate their commitment to the industry, their colleagues and their business.
- **Support:** applicants need to demonstrate how they have supported others during the pandemic.
- **Contribution:** applicants need to show they have made an outstanding contribution to their workplace – in particular, areas or projects where they have exceeded expectations and made a positive impact on their business or a project.
- **Success:** applicants need to demonstrate how their contributions have made a difference to their business, colleagues or the industry.

## Eligibility

The applicant or applicants must:

- Be in full time employment in the highways or transportation sector within the Yorkshire and the Humber Region.
- Individual or Individuals nominated by a business or a member.

## Judging

An independent panel of judges will review the criteria and judge on the merit of the information provided.

Entries failing to meet the specified criteria or which are not submitted in the requested format will not be considered.

## Entries & Submissions

The entry should take the form of a maximum 1,000 word submission giving details of how the applicant or applicants have met the above criteria. This document should include a photograph of the applicant or applicants and of their submission. This information may be used as a part of the presentation.

As the ceremony is virtual this year, the judging panel would appreciate a 2 minute long video presentation from the applicant or applicants or the business introducing themselves and their submission. This video may be used during the virtual ceremony.

The submission should be made electronically by Friday 27th August 2021 and the winner will be determined at a meeting of the Yorkshire & The Humber Region Awards Sub-Committee.

## Award

The winner will be announced during a virtual awards ceremony which will be held on **September 24<sup>th</sup> 2021**.

Due to the Covid19 situation, an in-person awards ceremony will not be held this year. The virtual ceremony will be published on the CIHT website. It is expected that the applicants will be present during this virtual ceremony with voice and video capability.

This is a one-off award and a bespoke trophy will be commissioned for it.

### Submission of entries

1. Entry is free.
2. Submissions must include a completed entry form. If you are entering more than one award, please complete a separate entry form for each award.
3. Submissions must clearly explain how the entry meets the criteria specified. Entries are limited to 1,000 words only. Submissions will be accepted over this length but will be judged on first 1,000 words. The entry document should be in Microsoft Word or PDF format, submitted with the official entry form by e-mail.
4. A 2 minute video of the applicant or applicants or businesses presenting themselves and their submission is requested, but is not mandatory. If the applicant or applicants or businesses is shortlisted, it is requested that this be provided to assist with the ceremony at a later date. .
5. All entries are to be submitted electronically.
6. Entries may be accompanied by supporting material (eg. illustrations, plans or results of monitoring studies) in electronic format, but these will be viewed at the judge's discretion.
7. Entries made by individuals must be endorsed as being supported by their employer or nominee (see Entry Form).

8. All material submitted will be treated as available for publication in awards-related articles within Transportation Professional and promotional materials developed for the Awards, unless otherwise copyright protected.
