### Sustainable Transport Measures Grants – 2020 **Annual report**



In September, the National Transport Authority published its Sustainable Transport Measures Grants (STMG) annual report detailing the increase in spending for year 2021.

The STMG programme, which provides funding to local authorities. public transport bodies and other agencies has

been operated by the NTA since 2010.

According to the report, major projects progressed include the Dundrum and Blackrock enhanced access programmes which introduced a re-arranged one-way system for vehicular traffic, with a contra-flow cycle lane The second stage consists of the implementation of in order to create safer, more accessible spaces.

The programme aims to improve transport options for those choosing alternatives to the private car. The funding has become an important driver of change within the urban centres across the country.

## TII launches enhancing Motorway Operation Services (eMOS) programme to help keep the M50 safe

Last September, the Minister for Transport announced the launch of Transport Infrastructure Ireland's enhancing Motorway Operation Services (eMOS) programme.

Through the implementation of intelligent transport systems (ITS) technology, eMOS will enable motorway operators to slow traffic in response to collisions, roadworks, adverse weather conditions and congestion; enhance safeguards for emergency responders dealing with incidents on the M50; and keep road users better informed about incidents ahead and how they may affect their journey.

It optimises road safety, enhances the efficiency of the road, and improves journey time reliability by reducing

the number of 'stop and starts' that take place along the M50 and the need for drivers to brake suddenly in response to standstill traffic.



The programme is being rolled out in an incremental manner. The first stage comprised the expansion of the existing Dublin Tunnel Control Building to provide a new, state-of-the-art motorway operations control centre.

cutting-edge intelligent transport systems (ITS). It is being rolled-out in a phased manner, with the first digital signs being switched on between Junction 4 Ballymun and Junction 6 Castleknock in autumn 2021. This incremental approach will allow road users time to familiarise themselves with the new signs and adjust their driving behaviour accordingly in advance of the introduction of regulatory speed limits.

### **Opening of Dodder Greenway Bridges**

The Dodder Greenway is envisaged to be over 17km long, linking Sir John Rogerson's Quay in the City Centre to the entrance to the Bohernabreena reservoirs at Glenasmole, South Dublin. As part of the bridges phase of the Dodder Greenway initiative, South Dublin County Council has built three new pedestrian and cycle bridges, 750m of new pathway and 2.6km of upgraded paths.

The opening of the bridges is a key milestone in the overall Dodder Greenway vision to link Dublin City Centre to the Dublin Mountains via Ballsbridge, Milltown, Rathfarnham, Firhouse and Tallaght. The South Dublin County section of the Greenway stretches from the Bohernabreena Reservoir in Tallaght to Orwell Park in Rathfarnham.

National Development Plan 2021-2030



In October, the revised National Development Plan (NDP) was • launched by the Government. The document sets out the Government's investment strategy and budget for the period 2021-2030. incorporating an investment package of €165 billion.

According to the document, the NDP is

envisaged to play an important role in shaping the responses to the challenges of the present, and to prepare for the challenges of the future. The public investment approved by the Government and detailed in the new plan will play a significant role in addressing the opportunities and challenges faced by Ireland over the coming years from issues such as Covid-19, Brexit, housing, health, climate action and a population projected to grow by one million between 2016-2040.

A selection of investments outlined in the NDP is outlined • below:

- Better public Transport through the Connecting Ireland bus programme.
- Replacement of the Dublin-Belfast Enterprise train fleet.
- Enhancement of inter-regional bus services
- N/M20 Cork to Limerick.
- BusConnects for Ireland's Cities.
- Commuter Rail Regional Cities, MetroLink and DART+.
- Greener and Cleaner Bus Fleets.
- Completion of new parallel runway for Dublin Airport.
- Completion of investments at Dublin Port, the Port of Cork and Shannon Foynes Port.
- Dublin port MP2 Project two new berths.

Under the National Strategic Investment 4 (NSO 4) – Sustainable Mobility, there are 5 strategic investment priorities as outlined below.

- Active Travel: over the next 10 years approximately €360 million per annum will be invested in walking and cycling infrastructure in cities, towns and villages across the country.
- BusConnects: the project is envisaged to enhance the capacity and potential of the public transport system by increasing and replacing the bus fleet withs with low emission vehicles and introducing the Next Generation Ticketing and cashless payments. It is expected that, over the lifetime of the NDP, significant progress will be made on delivering BusConnects with the construction of Core Bus Corridors expected to be substantially completed by 2030.
- DART+: it is envisaged to be a cornerstone of rail investment within the lifetime of Project Ireland 2040. The program comprises a number of infrastructural projects – DART+ West, DART+ South West, DART+ Coastal North to Drogheda via Balbriggan, and DART+ Coastal South – and also a significant expansion of fleet, both batteryelectric and electric multiple units.
- Light Rail / Metro: Metrolink is likely the largest ever public investment project in the history of the State. The funding from the NDP will allow the project to move off the drawing board and into construction. In relation to light rail, the plan will permit the Luas Finglas project continue to progress in the coming years and will also fund the continued development and design of the proposed new east-west transport corridor in Cork
- Regional Cities Commuter Rail: funding provided over the next 10 years will support the Cork Commuter Rail Programme, the further development of commuter rail in Galway and Limerick, including the development of a new Limerick commuter rail network with new stations on each of the historical rail lines.

# A Day in the Life of

Senior Lecturer & Chair of MSc in Top of in-tray sustainable Transport and Mobility, **TU Dublin** 

### Terms of Reference

Teaching and research on topics relating to how physical and social neighbourhood characteristics influence people's decisions around walking, cycling or using public transport that can result in higher car dependency, social isolation and a more sedentary population, all which impact on population health and carbon emissions. ### Suitability for the job

BE in Civil Engineering; MEngSc in Asphalt Technology & PhD in Behaviour Science - Walkability. Over 20 years' experience as an educator in a variety of roles in Sport, Community Development and Academia. Other professional roles included highway design, transportation and development planning and traffic engineering (private sector), community sports development (voluntary sector and semi-state) and health policy (post-doctoral work).

### Where based

I have an office space in TU City Campus in Bolton Street where most of my teaching happens but my day-to-day location can vary greatly. International research and speaking commitments meant I was away a lot pre-COVID. I would also attend a number of Irish workshops. But like others, most of this has happened from my home over the past 18 months.

### Transport to work

The flexibility of my work and tight time restrictions because of family commitments mean this can vary a lot. Bus is my default but walking and cycling give me more predictability. After getting knocked off my bike in 1999 it has taken lower traffic volumes during COVID to get me back on my bike for more than local trips. I really wish I

could get rid of my car but Dublin needs more supportive routes to go places other than the city centre for me to do so!

Promotion of the Walk21 Ireland conference and Parttime MSc in Sustainable Transport and Mobility which is open for applications for January 2022 start. Plus, 2 draft PhD dissertations awaiting feedback. There is never a clear inbox or in-tray in academia!

### Best aspect of job

Seeing graduates making their impact on the world applying what they have learnt/ produced. Constantly learning through working with a diverse group of people from undergraduates to international experts, community groups to politicians.

### Worst aspect

The workload can get really intense at certain times of the year but being able to tune out over the summer months really helps.

### What is the most important transport issue today?

Communication. The polarised discourse in the media around investment in roads versus sustainable modes is often ill-informed and makes project implementation problematic. It isn't an either/or and there is not enough emphasis placed on the evidence based social and economic issues related to transport poverty/ car dependence and the health and environmental impacts of decisions.

### How do you relax?

Hanging with my family and friends. I love being around people and the ocean.

### Ambition

To see the network of professionals engaging in a people centred approach to transport engineering and planning grow so it becomes the normative practice to make the healthiest and most sustainable choice the easiest choice for everyone.

First course in Republic of Ireland approved for Transport Planning Professional



For the first time, a course outside the UK has been approved as meeting the knowledge requirements of the Transport Planning Professional qualification. The MSc Sustainable Transport & Mobility at Technological University Dublin has been approved by the Professional Standards Committee and graduates from the course will be eligible to take the standard route to Professional Review.

**Cat Goumal**, CIHT's Head of Education and Professional Development said, 'We're delighted that this course has been approved for the Chartered Transport Planning Professional and look forward to receiving applications from TU Dublin graduates."

This course is co-delivered by both the School of Civil & Structural Engineering and the School of Transport Engineering Environment and Planning in Technological University Dublin. Programme Registration is currently open for January 2022 start. Further course information is available below:
