#### **TPP Results**

The Professional Standards Committee, formed of nominated CIHT and TPS members, ratifies the reviewers' recommendation and ensures that an auditable trail is available to allow feedback to all TPP candidates. Results are normally issued within 8 weeks of submission.

The PSC meets 4 times a year. The next meeting is on 6 February 2014.
