## **Council Update**

#### **March Meeting**

CIHT Council is made up of elected ordinary members and regional representatives. They act as the decision making bodies for the CIHT, delivering the strategy, business plans and outputs on behalf of the membership. Council generally meets four times per year.

Highlights from the March meeting included a presentation from David Quarmby of the Rees Jeffreys Road Fund, on their report "Major Roads for the Future" - a long-term vision of the nature, role and development of a major road network in England, to 2040. Since commencing two years ago, the study has faced an ever changing political landscape, including the devolution agenda, but is now in its final straight with an emerging core proposal that is undergoing extensive consultation over the next few months. An update was provided on the consultation process for the CIHT Business Plan for 2017-22, including key issues raised and their outcome. Draft layouts, graphics and visuals were circulated for comment and feedback. The new Business Plan is due to be published in the autumn.

At the Membership & Skills Strategy Board, which is one of a number of technical panels individual Council members sit on, we had an update on membership statistics and current recruitment/retention strategies. There was further progress made on delivering a CIHT Annual Recruitment Fair, tentatively scheduled for early 2017, the launch of CIHT careers materials, and development of the Transport Planning Technician Trailblazer Apprenticeship. Finally, an update on evaluating the Mentor Match Me pilot in London was given, with a view to rolling the initiative out across the regions.

- Engineering Technician (EngTech).



## **CIHT Bulletin: Reviews of Recent Events**

#### Road Safety Seminar, November 2015 John Barrell

Around 40 people attended a very good day at County Hall, Durham, to hear a range of national and local speakers on various aspects of 'Developments in Road Safety'.

The morning started with Lindsay McConnell (AECOM), winner of the SoRSA Young Professional Presentation for 2015, deliver an interesting analysis of the relationship between gender and young child casualties. Alan Kennedy of Roads Safety GB then delivered an insight into their expanding role in professional road safety education.

John Barrell of TRL, and branch Treasurer, delivered a talk on the implications of HD19/15 for local authorities and the developing role of the International Road Federation in Road Safety Audit internationally. This was followed by Richard Owen from Road Safety Analysis illustrating ways of integrating data sources to understand better the causes and locations of collisions. Sandra Brown from Highways England then spoke about the development of new guidance for cyclists on the strategic road network.

After lunch David Davies of PACTS talked about the changes in road safety nationally since 2010 and the concern of the potential increase in casualty rates. Fiona Robertson from Green Welly Stop then presented a motorcyclists perspective of the road network. The event concluded with a group presentation from AECOM and Grontmij on the use of BIM models in major scheme design and the opportunities that this presented for safety audit, using the A1 upgrade between Leeming and Barton as an active case study.

### Queensferry Crossing, January 2016 John Jeffrey



The talk on the new Queensferry Crossing was given by Lawrence Shackman, the project manager for Transport Scotland. Lawrence has been involved from the very early days of the project and covered the concept, design options and various proposals and took us through to the final design and the work behind the arrival at the preferred bidder, preliminary stages of construction and bringing us up to date with the current stage of the project at January 2016.

He gave an enthralling presentation on the tremendous amount of work which has gone into the project from all parties and went into great detail on some of the very interesting and innovative engineering solutions which were arrived at on almost a day by day basis.

This was a joint meeting with ICE and IStructE and it is hoped that a further talk will be given upon completion of the project.

#### **Maintaining Transport Structures, February 2016** John Jeffrey

The talk on the Maintenance of Highway structures was given by Graham Yates, Engineering Technical Manager (Building & Structures) for Nexus.

Graham looked at various aspects of what is needed to keep our infrastructure up to date and focussed on the asset management of the various types of structure from Bridges to culverts and retaining walls.

Various testing techniques were briefly highlighted, but it would be useful to have further presentations encompassing more detail and opportunities for discussion in the future.

This presentation was of particular interest to our younger members who were grateful to gain an insight in such procedures.

# Presidential Visit and Young Professionals' Papers Evening, March 2016

On 9th March we were delighted to welcome CIHT President Sue Sharland and Chief Executive Sue Percy to the region. A day of activities were planned aligning with the President's theme for the year: 'Intelligent Transport in a Connected World'

Following a welcome reception held at Newcastle University, our first port of call was a seminar at the Transport Operations Research Group (TORG). Myriam Neaimeh presented findings from Real World Electric Vehicle Trials which provided a very interesting and comprehensive update on recent research on many aspects of the uptake of electric vehicles. Her presentation reviewed perception and barriers to using EVs, how technology has extended the average range of these vehicles, charging options (including networks of Rapid Charging Points) and the potential impact on UK carbon emissions with the increasing EV fleet size.

Our next visit was to the North East Combined Authority (NECA) Urban Traffic Management Centre (UTMC). Ray King outlined the history, capability and operation of the UTMC and showed us the operations room. He also described their involvement in an EU project called COMPASS4D, and their focus looking at energy-efficient intersections.

Next on the agenda was a roundtable discussion with Mark Wilson, Head of Transport Policy for NECA and North East LEP, and David Bartlett from the NEXUS Passenger Transport Executive. Discussion points included the NECA 20 year Transport Manifesto for the north east, the opportunities as Transport for North (TfN) develops and CIHT engagement with shaping the debate and development of the vision for transport and delivery. David provided an update on the new smart ticketing introduced on the Newcastle metro (the POP card) and how smart ticketing might develop across TfN. We also talked about other innovations in the region with extensions to the UTMC, the focus on EV and development of charging infrastructure.

The visit culminated with the annual CIHT Young Professionals Papers Evening held at Northern Stage. The five finalists were:

- Vincent Muller, Jacobs Airport Surface Access Modelling
- · Michael Dodds, WSP | PB Durham LSTF: Local Motion
- James Macpherson, AECOM Twickenham Station Pedestrian Modelling
- Bradley Sparkes, Northumbria University, Highway Asset Management for Extreme Events
- Peter Conlan, Milestone Transport Planning The Economic Efficiency of Traffic Management Systems

The standard of presentations was extremely high which made the judges' task difficult to choose the winner. The eventual winner was **Michael Dodds** for his presentation on Durham's LSTF Project: Local Motion'.

## A Day in the Life of...

Job title: Associate Director, Milestone Transport Planning.

**Role on Committee:** Member of the NE&C Annual Dinner Delivery and Sponsorship Group.

Terms of reference: I am responsible for developing the business within the North of England and Scotland. Effectively that takes me anywhere from Birmingham to Inverness! Milestone is a specialist Transport Planning consultancy that focuses on delivering a comprehensive service to private and public sector Clients. Our core business revolves around providing highways and transport advice through the planning process, but we also offer a 'one-stop' solution to our Clients for all aspects of transport planning, highways scheme design, environmental planning, development implementation and operation.

Suitability for the job: I am an engineer "at heart" with a BEng (hons) degree in Civil & Environmental Engineering from Leeds University and as well as being a Member of the CIHT, I'm also a Chartered Member of the CILT. Over the past 15 years I have been working mostly in the transport consultancy sector and all of it based in the North of England, despite being an Essex-boy originally.

Where based: I head up our new office which has just opened in the Gateshead International Business Centre, but am regularly out and about meeting Clients and travelling to our other office in Guildford.

**Transport to work:** To get to the office it's a car, I'm afraid. In my defence, once I'm here I walk or use public transport as much as possible, but my commute would take twice as long by any other method. At least my current car (a boring diesel) is much more efficient than the 15mpg I got from my previous car – a 90's Saab turbo!

**Top of in-tray:** Agreeing the masterplan layout and highway infrastructure work for a 3,000 home, new school and neighbourhood centre development to the west of Newcastle.

Best aspects of job: Getting out and meeting people. Whether that be new or potential Clients, or students through the course I run at Newcastle University, I like the social aspect of the job as much as the technical side of things. I've found that if you can build a relationship with people, you can better understand their wants and needs in a project, allowing you to provide a more bespoke service that gives them a much better end product.

**Worst aspect:** We're only a 'small' consultancy, totalling about 15 people at present, so while that means we are all focused on delivering exactly what the Client wants, it can be difficult juggling the demands of numerous projects all at the same time. Still, that's part of what makes the job fun too.

What is the most important transport issue today?: In the North as a whole I think it has to be the lack of connectivity to the rest of the country. Whether that be physical links such as the A1 / A1(M) and mainline rail services, or cognitive links regarding how the rest of the country sees us. We need to work on both if we are to continue to grow and regenerate as a region.

The recent investment in the A1 around Newcastle should be lauded, as should the improvements to the A19 which are due to start. Also the recent announcement of further rail services on the ECML are pushing the region forward, but they won't help unless we can encourage people to trade with us here in the North.

Both Cumbria and the North East can be seen as so remote to the rest of the country that many people I speak to (in London, in particular) think that "The North" stops at the Leeds/Manchester corridor and there's nothing from there to the central belt of Scotland. We need to work to change this perception or else we will never capitalise on the investment in transport projects around the region. Those infrastructure projects I've mentioned help in two ways, through adding desperately needed capacity on the transport network as a whole, but also through raising the profile of the area. The national media coverage of Nissan's investment, Sunderland's new bridge, the A1 western bypass upgrade, and dualling north of Newcastle, and a potential new power station on the Cumbrian coast not only serve to show that the region is investing, but also that we have the transport infrastructure, local workforce and unrivalled enthusiasm to offer to the wider country.

It's that connectivity, physical and mental, that we need to keep working hard to provide.

How do you relax?: I'm a keen runner and participate in as many events as my time allows – unfortunately (or should that be fortunately?) most of my time is taken up by the business and spending time with my family. That said, running round after two kids can be tiring enough, and you can often find us walking or cycling along the Derwent Walk, the route of the old Consett to Sunderland railway. I also enjoy music and always have something playing in the background, be it in the car, whilst out training, or even in the office.

**Ambition:** To see the Gateshead office, and therefore the business as a whole, continue to grow. We have an ambitious plan to double our staff numbers by the end of 2016, which we are well on course for at the moment – just need to keep those projects coming in now.
